¹ Per Section 5.A.1.ii of the NOAT II Trust Distribution Procedures, NOAT II Funds shall be allocated to each Non-SAA State as (a) Regional Apportionment or (b) Non-Regional Apportionment based on the amount of NOAT II Funds dispersed under a confirmed Chapter 11 Plan as follows: A. **First \$260 million** – 70% Regional Apportionment/30% Non-Regional Apportionment; B. **\$260 million - \$650 million** – 64% Regional Apportionment / 36% Non-Regional Apportionment. NOAT II Funding Cycle 1 totaled \$153 million. NOAT II Funding Cycle 2 totals \$180 million. Per the NOAT II TDP, \$107 million (59.44%) of the NOAT II Funding Cycle 2 monies carries a 70% Regional Apportionment/30% Non-Regional Apportionment; and, \$73 million (40.56%) of the NOAT II Funding Cycle 2 monies carries a 64% Regional Apportionment/36% Non-Regional Apportionment.
